# 4. PUBLIC SESSION

A member of the public attended the meeting and raised their objections to Planning Application PA/2024/1986. They also raised their concerns about the ongoing parking problems in Chapel Road

#### 5. BOROUGH COUNCILLORS REPORT

Cllr C Bell advised that she followed up with KCC Highways concerns about the tarmac slope on The Street/Bethersden Road and that highways will revisit the site when they return to install the village gates.

An update was provided on the Bluebells Childrens' Centre, whereby KCC are looking to provide a satellite teaching unit for a local Ashford school at Bluebells for 18 months as of January 2025.

Chapel Road Parking. Cllr Bell agreed to look further into the possibilities of permit parking in this location. This would require a residents' consultation and, although unusual in a rural setting. it may be worth looking at as an option for residents, particular given the number of cars parked that do not appear to be owned by residents within Chapel Road or Chapel Row. It was suggested that expansion of the road (on the left-hand side) could also provide further parking. The PC asked Cllr Bell to ask an officer to come and look at this as a possible solution.

Cllr Bell advised that the council have now moved out of the Civic Centre to International House. At present only the Officers have moved, the Civic side and the Chamber are still within the Civic Centre.
