7. <u>A20 OVERNIGHT LORRY PARKING RESTRICTIONS SCHEME</u>

The report from the JTB Meeting held on 11 September was circulated to all councillors on 19 November.

The improvement in overnight and over-weekend conditions along the A20 is transformative for residents and for road users.

A recent planning application has been granted, subject to a Section 106 Agreement which would increase the capacity of the current lorry park and it is also hoped that the "Bellamy Gurner" A2070 Orbital Park upgrade scheme which would provide a signalised junction on a "all movements" basis will come forward sooner rather than later.

The scheme is to be reviewed with a view to assessing the possibility of carrying it on after the pilot period ends.

Councillors agreed that concerns that the scheme would simply move the problem to another area in the Ashford Borough have not come to fruition.

Crime Reports

I have looked at the crime reports from the 1^{st} October $2018 - 30^{th}$ November 2018. Crime remains extremely low within Hothfield.

Anti- Social Behaviour

There have been no reports of ASB in the area over the last month. However, I have attended call's reporting about youth's hanging around in the play park. I have dealt with them accordingly and have informed them about the car being moved from the field. I hope that this has now been resolved. As Christmas is approaching please could everyone take necessary steps to secure their property the best they can as burglaries tend to rise this time of year in and around Ashford.

Steps to secure your property

Keep front gate closed at all times

Lock all external doors.

Spotlights can help deter offenders.

Alarm System- particularly those linked to the police can deter offenders and help police attend incidents swiftly.

Timer switchers- for lights when you are out at night or on holiday.

Keep windows closed particularly at night in the warmer months.

Alarms for out buildings

Lock sheds and garages

Mount CCTV to deter and capture evidence of offences.

Dash Cam footage can be used in relation to vehicle crime

Dangerous Junction at Chapel Row

Nothing to report.

Anti-social Behaviour at Recreation Ground

The youths are still causing a nuisance and leaving large amounts of litter on the MUGA. They are also switching the lights on but not using the MUGA for sporting activities.

The Clerk will inform the PCSO and ask him to ensure that he continues to patrol the area to ensure that the youths do not to drive on the grass and clear up their litter.

We are still waiting for a reply from KCC regarding the possibility of installing bollards to keep cars from driving on the Recreation Field.

Parking Issues around Hothfield

The issues previously brought to the attention of the Council have been resolved.

The Clerk will contact the PCSO and ask him to tell residents not to park on the path on the junction of The Street and School Road or on the zig zags in School Road as it is illegal.

Meeting with Southern Water

Mr Lloyd met with the Project Manager from Southern Water who explained that the contractors have been faced with various issues as they were having to dig under listed buildings and this has held up the work considerably. He apologised for the inconvenience being caused to the village.

Southern Water will be carrying out a mail drop along School Road, West Street and The Street, explaining the work to be done and that it will take 9 weeks to complete. Traffic management will be in place during this time.

Mr Lloyd will contact the Project Manager regarding the trench that has been dug in front of 10 - 15 West Street, which is actually private land and has only been temporarily filled in with dirt, thereby making it difficult to walk and drive over and making a tremendous mess. He will ask for the trench to be filled with a permanent filling.

Report from KALC Meeting

The Minutes of the meeting held on 14 November have been forwarded to all councillors.

Mr Lloyd reported that the District Police Commander informed those present at the meeting that there has been a rise in crime across the UK of 8%, but in Kent it is 20%. He puts this down to the way crime is reported in Kent. A single crime with more than one element would, in the past have been logged as one crime but all elements are now recorded as separate crimes, thus increasing the perceived crime rate.

County lines are also an issue. If a criminal is removed from London to a rural location, they will often contact their previous associates and set up a drug mule service, thus moving the problem from London to another area. There have been 2 significant raids in Ashford recently

Regarding villages local to Hothfield, a member of Charing Parish Council reported problems of antisocial behaviour, including vandalism, drink and drugs, arson and cruelty to farm animals and a site in Westwell is known to have been involved in serious crime.

The Village Confines exercise was discussed and an update given on the Local Plan which is with the Inspector. A report is expected in December with possible adoption in February.

2019 Election

Councillors were reminded that Parish Council elections are due to take place on 2 May 2018.
