9. INSURANCE ARRANGMENTS

The clerk had issued copies of the quotations received from Came & Co and Zurich Insures. The PC agreed that Hothfield PC should accept the quotation from Zurich.

10. CCTV Update

The PC agreed to proceed with the quote received and to go ahead with the survey regarding CCTV siting in the village.

11. Speed Restriction Update

It was agreed that the PC would proceed with the quotation from KCC Highways. Cllr Sutcliffe confirmed that she had suggested to KCC that prior to works commencing the company doing the work meet with Councillors on site to clarify the scheme.

12. <u>Muga</u>

No inspection had taken place. Concerning the supply and installation of a new sign, Cllr Pollock had chased the company for a correct invoice.

13. Ashford Plan 2041

Cllr Lloyd reported that ABC are holding 8 community events and two virtual events, dates and location to be confirmed. At present there is no information on the release date of the plan. Cllr Pollard suggested that HPC hold a public meeting with residents before the ABC meeting. Cllr Lloyd will consult with Westwell Parish Council about holding a joint meeting once the information pack has been released. Action Cllr Lloyd

14. Hothfield Newsletter

A delivery person was required for Beech Drive. This has been advertised in the newsletter

15. Coronation Orchard

Cllr Cox has put forward a number of potential sites and is awaiting feedback on the 4 proposed sites including two near the old school, 1 near the children's play area and 1 near the old Brownie hut. A discussion followed on other potential sites. Cllr Cox will update the PC further as this item progresses.

16. Tree Preservation Order

AW167. Cllr Brock confirmed that he had submitted an application regarding the tree although it transpired that the tree had already been cut prior to him submitting the application. It remains unknown who cut the branches. Cllr Pollard expressed his concern as, from a legal perspective, this would mean that Cllr Pollard could not take responsibility for any damage that may or may not have occurred when the tree was cut back to the surrounding fencing as it is unknown who authorised the cutting of the tree branches.

17. Correspondence Received

- The clerk brought to the attention of the PC that Park Drive will be closed for vehicle access from August 5th There will be no access to the village hall car park. Station Road is also closed on the 17th June for 2 days for resurfacing works.
- KALC and Citizens Advice. A proposal for a tablet device for Hothfield to assist residents has been made. Unfortunately, the scheme would not be suitable for Hothfield as the village hall is not manned and is not accessible throughout the day.

18 Village Hall Report

Cllr Lloyd attended the AGM 20th May. The committee positions were re-appointed and remain the same. Although at present their bookings are healthy, their overall accounts show their expenditure over income is £8k per annum. The PC were concerned as this was not a sustainable position long term.

19. KALC Report

Cllr Cox was unable to attend the last meeting, therefore no report was presented to the PC.

20. Forum for Information

- A complaint had been made to ABC about how Kent Wildlife Trust are managing Hothfield Heathland. Various concerns had been highlighted in the complaint. The PC were not aware of the allegations cited and the complaint will remain with ABC to act upon.
- Cllr Fletcher will correspond with KCC directly re the closure of Hothfield Children's Centre and will also raise the concern of vegetation on Station Road footpath.
- The Craft and Flower Show will take place on the 11th August. Details to follow in the Hothfield newsletter.

Chairmans

- Fence along the village green. A request to replace the fence has been put forward to Aspire. Cllr Pollard agreed to look into this further on behalf of the PC.
- The Street has a number of areas where the hedges are growing out onto the pavement restricting the width. It was suggested that the PC request that Kent Highways issue a letter concerning this.
- It was requested that the chairman elaborate on the bullet points in the Hothfield Newsletter summarising the PC meetings
